

Used car dealers admit fraud

David King and his daughter Danielle King, who ran Auto Direct Car Centre at JBJ Business Park in Blisworth (until August 2010) have pleaded guilty to a total of 14 counts of fraud.

We received complaints about the double sale of vehicles, non return of deposits and clocked cars.



The “double sales” involved the business selling a car to one customer, then before that customer took delivery of the car, selling it again to a second purchaser for more money. The first purchaser was then incorrectly told that there were problems with the car and given the option of having another car from Auto Direct or having a refund. The business then deliberately delayed finding an alternative vehicle or providing a refund.

David King, who pleaded guilty to 12 charges of fraud by false representation, was sentenced to a 10 month prison sentence, suspended for 12 months, and ordered to carry out 180 hours of community work. Danielle King pleaded guilty to two similar charges and was sentenced to 100 hours community work.

Three rogues jailed following cross county fraud investigation



A rogue roofer who defrauded vulnerable consumers has been jailed for four years following a successful operation between Trading Standards and Police in Northamptonshire and Leicestershire.

William Wallace of Market Harborough, pleaded guilty at Leicester Crown Court to nine charges of fraud. The victims, who ranged in age from 70 to 88, were cold called, advised that unnecessary work needed doing and paid for work that had not actually been carried out.

The offences came to light when a building society cashier in Desborough became suspicious about a request from a customer, who had been escorted there by Wallace, to raise a cheque for £7,600. The cashier refused to grant the cheque and raised concerns with us.

Enquiries found that in the previous three months the victim had paid three cheques totalling £21,600 for work to her property. A surveyor examined the work and valued it at £900. As the investigation proceeded, it became apparent that similar offences had been committed in Leicestershire and Suffolk during 2011.

Lee Warburton and Craig Taylor of Market Harborough pleaded guilty to charges of money laundering as they had helped Wallace by processing cheques through their bank accounts and then giving Wallace the cash. They were each jailed for six months.

Second jail term for rogue trader



Gary Allbones, who was a supplier of garage doors has been sent back to prison for just over 18 months for failing to pay a Confiscation Order of £54,000.

Allbones was convicted (February 2011) of operating a fraudulent business where garage doors were supplied very late and in some cases not supplied at all. Allbones who repeatedly misled his customers has already served a 10 month jail sentence for these offences. He will still have to pay the Confiscation Order when he is released from prison.

Scammer convicted after joint investigation

Fraudulent company director Mark Gaffney has been jailed for three years for fraud thanks to the combined efforts of a number of agencies.

The offences first came to light after we received 20 complaints from Northamptonshire residents about the trading practices of National Maintenance and Arena Maintenance who carried out heating maintenance. Gaffney made unauthorised transactions totalling £144,900.00 from customer bank and credit accounts after they handed over bank cards to pay for work done. Some victims had lost thousands of pounds.



Due to the businesses being based in Bedfordshire, the case was passed to Central Bedfordshire Trading Standards and Bedfordshire Police to be prosecuted.

83,000 illegal cigarettes seized



A crackdown on illegal tobacco by us and Northamptonshire Police has resulted in a series of seizures across the county. This included one premise where 2,500 packs of cigarettes were discovered hidden in a concealed room. 1,900 pouches of hand rolling tobacco were also found with the help of a trained sniffer dog. Northamptonshire Police seized a large quantity of cash and two vehicles associated with criminal activity at one address.

All tobacco sold in the UK must have a picture warning and English wording on its packaging. Illegal tobacco costs the UK economy nearly £3billion in lost tax revenue and is often linked to other criminal activity such as drugs and people trafficking. It is estimated that 22% of cigarettes smoked in the East Midlands avoid UK tax.

Illegal tobacco, which is sold at lower prices, harms the interests of honest businesses, who only stock legal products.

Warning – Giant lighters could ‘detonate’ causing injury

We are warning the public about the sale of dangerous giant lighters (approximately 16cm tall) which do not meet relevant safety standards.

Recently 136 were seized from a shop in Northampton and subsequent testing found that when the lighters were dropped they ‘detonated’ producing a cloud of flammable gas and flying debris which could cause burns to anyone in close proximity. The lighters have a torch at the bottom which increases the risk of ignition.

Fire hazard furniture supplier fined

A national furniture supplier has been fined £3,325 plus £2,675 costs after pleading guilty to supplying furniture not meeting fire safety standards.

We purchased an Iowa sofa bed from a Northampton retailer and submitted it for testing – the back cover fabric failed the relevant tests. The sofa bed was imported and supplied to the retailer by Sweet Dreams (Nelson) Limited of Nelson, Lancashire.

In 2010, we bought the same product and tests found the same failure. The company was informed and understood to have taken action to avoid future occurrences.

Research shows that fire safety standards save 54 fatalities and 780 injuries each year and therefore compliance with them is vital.

Unsafe Electric Blanket Recall

Morphy Richards has issued a product recall notice on its Over Electric Blankets range with the model number 75310 and 75312.

This range of over blankets were sold in the UK and Ireland through national and independent retailers and on Morphy Richards’ website between October 2008 and January 2010.

The blanket can develop a fault that has the potential to cause it to overheat and catch fire. As a precautionary measure, customers are asked to stop using it immediately.



Age restricted products – safeguarding young people

Underage sales results



Checks carried out between April and December 2012 resulted in six illegal sales of age restricted products from 96 test purchase attempts. Our target is to ensure that sales are below 10%, although we would obviously like to see no sales taking place. There has been a marked improvement in compliance in the last six years – in 2005/06 illegal sales were as high as 39%. This area of work is one of our priorities, along with tackling rogue trading, and we will continue to combine work to educate businesses with robust enforcement action where appropriate.

Corby stores have alcohol licences suspended

Two Corby shops have had their licences to sell alcohol suspended for two months and one month respectively following illegal sales to underage test purchasers.

Mini Sam, 80-82 Rockingham Road, Corby – two sales of alcohol to underage test purchaser within two months. Licence suspended for two months from August 2012.

Pysio, 64a High Street, Corby – two sales of alcohol to underage test purchaser on different occasions within three months and two incidents where non-duty-paid alcohol was found on sale at the premises without any business records to show where they had originated. Licence suspended for one month in January 2013.



Shop to pay £1300 for underage cigarette sale

Akniks ADS Ltd, t/a Brackley Post Office and Stores have pleaded guilty to selling cigarettes to a 16 year old test purchaser following complaints made to us. The company was fined £500, ordered to pay £798 costs and a £15 victim surcharge by Northampton Magistrates.

Magazine owner gives undertaking over horror DVDs

The owner of a Northampton based horror magazine has given an undertaking to comply with the law in relation to age warnings on DVDs following an investigation.

His business published magazines with free horror DVDs that had not been age rated by the British Board of Film Classification. The DVDs were labelled as '15' when four of the DVDs contained material requiring an '18' age warning.

A prosecution was brought, however on public interest grounds, an undertaking was accepted. The undertaking can be used in evidence should further offences be committed. Anyone with any information about underage sales can inform us by contacting Citizens Advice consumer service – details below.
